

#### **FLOAT UNITS**

A float shall consist of a low, flat trailer, mobile home frame or other suitable frame with pneumatic-tired wheels.

The final entry must adhere to the original concept. Any variation or change requires prior approval of the Parade Committee.

The following safety measures are required:

- Handholds or other support for participants standing on the float.
- Float material and costumes made of flame retardant material.
- A fire extinguisher aboard the float or propulsion unit.
- Safety-type couplers for all towing connections.
- Children under the age of 16 must be supervised by at least one adult.

Animation, costumes and music are encouraged.

The following size restrictions apply:

#### **INFLATABLE UNITS**

Unit is responsible for all components associated with unit such as volunteers or helium.

#### **BAND UNITS**

Bands are encouraged to perform over as much of the parade route as possible for the enjoyment of the crowd. Band performances will be judged while passing in front of the reviewing stand. Bands may be identified by banners or signs preceding the group or by signage that is an integral part of the group.

#### **EQUESTRIAN UNITS**

Transportation trailers or trucks of any kind may not follow equestrian units. Each unit is required to provide its own sanitation in the form of a pooper-scooper or diaper.

#### **WALKING UNITS**

Each walking unit must be costumed or have a choreographed activity or routine. This routine or act should be performed while the unit is moving at the parade pace and should continue along the entire parade route.

#### **GOVERNMENTAL UNITS**

Participant should be an elected official and not a representative of the official. Participants accompanying the elected officials will be limited to no more than five people. Participants need to pay the \$150 entry fee, provide their own vehicle, and limit signage to the official's name and title.













#### **Check List**

Please double check your application. Incomplete applications will not be considered by the selection committee.

- ☐ Parade announcement script. Include a brief description of your entry. Please limit your description to 50 words. This will be what the Parade Announcer reads when your unit goes by the judging stand.
- ☐ Unit sketch and/or photo as well as music description.
- ☐ Signed waiver for all units.

#### CERTIFICATE OF INSURANCE INFORMATION

Certificate of Insurance for all licensed motorized units showing liability limit not less than \$100,000 Bodily Injury and \$25,000 Property Damage or \$100,000 combined Single Limit. (Certificates of Insurance are available from your insurance agent. Examples of certificate of insurance is included in this packet.) Vehicle ID cards not accepted.

Equestrian organizations must provide Certificate of Insurance with General Liability limits showing liability limit not less than \$100,000 Bodily Injury and \$25,000 Property Damage or \$100,000 Combined Single Limit. (Certificates of Insurance are available from your insurance agent. Examples of certificates of insurance can be found on wichitariverfest.com.)

#### **Rules & Regulations**

The following rules and regulations are designed to keep the Star Lumber Sundown Parade a safe family event for everyone.

- The Sundown Parade Committee will make its decisions using your application; therefore, it is very important that your application be complete. Reminder: Entries are limited in the parade, so submitting an application does not assure acceptance into the parade.
- · All participants must wear a Riverfest button.
- An adult must supervise children under the age of 16 at all times.
- The number of vehicles and/or persons with each unit must be specified on the application.
- The maximum number of people permitted per entry fee is 35 with the exception of bands and military units.
- All drivers must be licensed and all vehicles in the parade insured (please refer to the Certificate of Insurance Information found in this packet).
- No gifts, literature, merchandise, balloons, candy or other
  materials may be handed out or thrown along the parade route.
   Do not encourage spectators to leave the sidelines and join the
  parade for any reason.
- · All vehicles must be approved by WFI.
- Smoking and consumption or possession of alcoholic beverages or illegal substances is prohibited.
- Use of political or controversial material on any entry is prohibited.
- All entrants are responsible for arranging for power, helium for inflatables or other supplies necessary for their unit.
- Performing units should plan routines which do not require that the unit stop. Units should always be moving as to not hinder the progress of the parade.

- All entrants are responsible for walking/inspecting the route before the parade to make sure their unit can clear any wires, trees, street lights, etc., along the route, including the staging areas. (Height restriction of 14 feet).
- All applicants will receive written notice of their application status from the Sundown Parade Committee by May 3, 2024.
- Any accepted entry that cancels after May 10, 2024 will not receive a refund of their entry fee.
- Each unit must appoint a Unit Captain to pace the unit and work with the Sundown Parade Committee.
- Unit Captain: Attendance at one of two staging meetings is mandatory for the Unit Captain and driver. At this meeting participants will receive parade packages with staging instructions, unit number and four (4) Riverfest buttons.
- Participants must arrive at their designated marshaling spot at the specified time (per acceptance letter instruc-tions) or they may not be allowed to participate.
- The Sundown Parade Committee reserves the right to bar or remove any entry from the parade that refuses to follow all instructions from parade officials and/or police.
- WFI reserves the right to accept or deny any parade entry.
- Line-up order is determined by the Sundown Parade Committee to establish variety and to ensure the even flow of the parade.
- Please keep in mind that incomplete applications will not be considered for entry and that the Sundown Parade Committee reserves the right to deny any entry at any time, should it detract from the basic purpose of Riverfest and/or the Star Lumber Sundown Parade.
